22	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
23	resolution may be cited as the "Contract No. CW108863 with La Clínica del Pueblo, Inc.
24	Approval and Payment Authorization Emergency Declaration Resolution of 2025".
25	Sec. 2. (a) There exists an immediate need to approve Contract No. CW108863
26	with La Clínica del Pueblo, Inc., and Modification Nos. M0001, M0002, and M0003 thereto, and
27	to authorize payment for the goods and services received and to be received under the contract
28	and modifications.
29	(b) On July 6, 2023, the Office of Contracting and Procurement ("OCP"), on behalf of the
30	Department of Behavioral Health, executed Contract No. CW108863 with La Clínica del Pueblo,
31	Inc., for substance use disorder outpatient treatment services, in the not-to-exceed ("NTE")
32	amount of \$700,000 for the period July 6, 2023, through July 5, 2024.

33	(c) On July 3, 2024, via Modification No. M0001, OCP exercised option year one of
34	Contract No. CW108863 in the NTE amount of \$700,000 for the period July 6, 2024, though
35	July 5, 2025.

- 36 (d) Modification No. M0002 increased the NTE amount of option year one of Contract
 37 No. CW108863 by \$280,000, from \$700,000 to \$980,000.
- 38 (e) Modification No. M0003 will increase the NTE amount of option year one of Contract No. CW108863 by \$620,000, from \$980,000 to \$1,600,000.
- 40 (f) Under section 451(b)(1) of the District of Columbia Home Rule Act, approved
 41 December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b)(1)), Council approval is
 42 necessary since the modifications will increase the value of the contract to more than \$1 million
 43 during a 12-month period.
 - (g) Approval is necessary to allow the continuation of these vital services. Without this approval, La Clínica del Pueblo, Inc. cannot be paid for goods and services provided in excess of \$1 million for the period from July 6, 2024, through July 5, 2025.
 - Sec. 3. The Council determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Contract No. CW108863 with La Clínica del Pueblo, Inc. Approval and Payment Authorization Emergency Act of 2025 be adopted after a single reading.
- Sec. 4. This resolution shall take effect immediately.
