A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. M0008, M0009 and M0010 to Contract No. CW110323 with Tag-B Parking, LLC, and to authorize payment for the goods and services received and to be received under the modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modification Nos. M0008, M0009 and M0010 to Contract No. CW110323 with Tag-B Parking, LLC Approval and Payment Authorization Emergency Declaration Resolution of 2026”.

Sec. 2. (a) There exists an immediate need to approve Modification Nos. M0008, M0009 and M0010 to Contract No. CW110323 with Tag-B Parking, LLC, and to authorize payment for the goods and services received and to be received under the modifications.

(b) By Modification No. M0008, issued on July 27, 2026, the Office of Contracting and Procurement (“OCP”), on behalf of the Office of the State Superintendent of Education, exercised a partial option of option year three of Contract No. CW110323 with Tag-B Parking, LLC to provide private student transportation and attendant services to eligible students in the not-to-exceed amount of \$990,000 for the period of August 22, 2026, through September 30, 2026.

(c) By Modification No. M0009, issued on August 31, 2026, OCP increased the not-to-exceed amount by \$617,376.96 to a total not-to-exceed amount of \$1,607,376.96 for the partial option period.

(c) Proposed Modification No. M0010 will exercise the remainder of option year three and increase the amount by \$17,102,831.04 to a total not-to-exceed amount of \$18,710,208 covering the period of performance from October 1, 2026 through August 21, 2027.

(d) Under section 451(b)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b)(1)), Council approval is necessary since the modifications will increase the value of the contract by more than \$1 million during a 12-month period.

(f) Approval is necessary to allow the continuation of these vital services. Without this approval, Tag-B Parking, LLC cannot be paid for goods and services provided in excess of \$1 million for the period from August 22, 2026, through August 21, 2027.

Sec. 3. The Council determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Modification Nos. M0008, M0009 and M0010 to Contract No. CW110323 with Tag-B Parking, LLC Approval and Payment Authorization Emergency Act of 2026 be adopted after a single reading.

Sec. 4. This resolution shall take effect immediately.
